Llan Ffestiniog

The background

The Trust started working on the site of Llan Ffestiniog Station with the permission of the Landowners (who are also both members of the Trust) and a good bit of progress was made towards improving the layout of the site and tidying up the mass of weeds and debris on the site. Quite a few weekends work has enabled an improved access to many areas of the site for the owners and members of the Trust.



This work enabled us to get a better idea of the layout of the land and enable us to plan future works in a more structured way. It also enabled the Trust and the site owner to access areas that were overgrown and chart out a split of the land that benefits both parties.








Llan Ffestiniog - Future

The Trust long term aim is to rebuild the old station building as it was prior to demolition (in full working order not in its decayed state!) with a view to using it as a base for all future activities of the Trust as well as enabling the creation of an exhibition of the line thus promoting the work of the Trust.

This is likely to be the first major project for the Trust, sadly there is no space on site to rebuild any of the other buildings including the old goods shed and carriage sidings but we will at least have the space to be able to recreate the station building again.



The current site has the remains of the village side platform in place and some of the footprint of the old station building. However it is likely that the old foundations will have to be removed in order to be able to rebuild a replica of the station as construction will need to be to modern standards.



The Trust currently does not have a lot of images of the old station site and is trying to find as many as it can from open sources and any other source that we can access. If you know of any more images of the station building please do point us in their direction so we can rebuild as accurate a representation of the old station as we can.

We would be especially grateful of any images of the internal structure of the building.

The Plans

Acquisition

The first stage is to ensure acquisition of the site and we are fortunate that the current owners of the site are very supportive of the project and its long term aims. This does not mean negotiations have not been easy!

The current draft agreement (subject to further negotiations and signing) is for the Trust to lease the site for a period of 5 years enabling the Trust to have stability with regards the site and allowing it to start to implement its plans towards maintaining and improving the site. Any more permanent changes would need agreement of the current landowners but it is believed that as they are good supporters of the project that changes (if any are necesary) should be possible to complete.



Once the draft agreement is signed it will enable the Trust to fence off the land covered in the lease. This fencing will be temporary to enable the Trust to establish its boundaries but also to enable the Trust to start planning its site maintenance works with a long term view towards creating a usable site for a rebuilt railway station / Trust base.



In the long term the plan is to replace the temporary fencing with a boundary wall built to traditional stone wall construction to further help the station to blend into the local environment.

The existing entrance on station road may be replaced by a replica GWR gate but this is subject to discussions once the lease is completed.

The money trail

The lease of the land will be for 5 years with a view to purchase in 5 years time. This gives the Trust stability for at least the next 5 years and enables it to carry out works aimed at supporting the rebuilding of the station.


To this end the Trust now needs to make financial plans to enable it to cover the cost of the lease over the next five years, cover the cost of maintenance works on the site as well as build up funds in view of its aim to complete the outright purchase of the site in 5 years time.



To help achieve its aims the Trust will need to register as a charity and at the time of writing we only need a minimum of 28 people donating £5 a month (plus gift aid) to achieve the necessary £5,000 a year to register as a charity.


To really give the Trust a comfortable level of fundraising over the next 5 years we need to aim for 100 members a year who also donate £5 a month. If we achieve this target we will comfortably be able to afford the annual lease charges as well as have a surplus in 5 years sufficient to cover the purchase of the land and costs associated with maintaining the land while it is leased to the Trust.

We look forward to welcoming your continued support and any new members who join us over the next few months and years.



Model Railway
